PURSUANT to Sections 17 and 126 of the Transport Act 1966, His Excellency the Queen's Representative, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

REGULATIONS

1. <u>Title</u> - These regulations may be cited as the Transport (Fees and Forms for licences) Regulations 1995.

2. <u>Form of application for motor driver's licence</u> - Every application for a motor driver's licence shall be in the form set out in the First Schedule to these regulations.

- 3. Form of motor driver's licence Every motor driver's licence shall be issued -
 - (a) In the case of the island of Rarotonga in the form set out in the Second Schedule to these regulations;
 - (b) In the case of every island other than Rarotonga, in the form set out in the Third Schedule to these regulations.

Provided that in the case of person who has been issued with a licence in Rarotonga, the form of licence issued to him shall be valid for use in any island other than Rarotonga, and in the case of a person issued with a licence on an island other than Rarotonga the form of licence issued to him shall be valid for use in Rarotonga.

4. <u>Application fees</u> - The fees payable for applications for a motor driver's licence shall be the appropriate fees set out in the Fourth Schedule to these regulations.

5. <u>Consequential amendments</u> - The enactment set out in the Fifth Schedule to these regulations is amended in the manner set out in that Schedule.
