## PREFACE TO THE "2012 REVISION"

The 2012 Revision is the compilation and codification of all the public laws passed by the Nitijela and incorporates those passed during the period 2008 to 2011. This is an updated version to the 2004 Edition (the status table below identifies the newly enacted laws and the provision of the 2004 Edition affected by these newly enacted laws). The last publication of Code was in 2004 with supplements published through to 2007. Since then, laws enacted during the period 2008 through 2011 are uncodified.

The Cabinet appointed the Law Revision Commission¹ on May, 2010, to review and codify all laws which have not been codified and to improve and publish a modern standard hard copy Code. To ensure timely access by the public to laws of the Nitijela, the Commission approved the process whereby updated versions of the Code be distributed in electronic format to be followed by the publication of hard copies of Code as funding becomes available for such publication. It is the Commission's view that most users of the Code has access to a computer or other gadget from which to access the electronic Code.

The authority to review and re-codify the laws vests in the Law Revision Commissioner, as required under the Revision of Laws Act of 1981. In the absence of the Commissioner, however, this role devolves, by default, to the Legislative Counsel.<sup>2</sup>

The reviewing and publishing of the Code is traditionally always a tedious and painstakingly long and arduous process. It is more so given that this process only occurs when the Nitijela is not in session. Notwithstanding the many hurdles and challenges confronted, the task is completed and this digital version represents the long hours of effort put into this endeavor.

I wish to acknowledge and express my sincere appreciation for the effort and contributions of Witten T. Philippo, Rosania Bennett, Karotu Tiba and Tion Nabau for their dedication without which the task would not have been timely completed.

A special thank you to Chief Justice Carl B. Ingram and former Legislative Counsel Filimon Manoni for their invaluable guidance throughout the process of revision and compilation. I would be remiss if I did not include in my words of thanks to Cathy Ralpho, the Legal Clerk, for her assistance in the process and for enduring my incessant demands.

## Acts re-organized and re-codified in other locations in the Code.

The 2012Revision also re-organized and re-codified several existing Chapters under other Titles of the Code which are deemed appropriate for the subject matter of the Act. The following Acts have been re-organized and re-codified:

- 1. <u>Industries Development</u> (formerly 10 MIRC 3); re-codified as 14 MIRC 6, and newly cited as the National Training Council Act.
- 2. Foreign Investment License (formerly 10 MIRC 5); re-codified as 36 MIRC 2.
- 3. Investment Incentive Agreement (formerly 10 MIRC 12); re-codified as 36 MIRC 3
- 4. Securities and Investment (formerly 18 MIRC 1); re-codified as 36 MIRC 1
- 5. Republic Resident Representative (formerly 3 MIRC 13); re-codified as 43 MIRC 9.
- 6. Motorcycle and School Bus Safety (formerly 7 MIRC 6); re-codified as 13 MIRC 6.

## **New Title**

The only Title that is re-codified during the 2012 Revision is <u>Title 36</u>- This Title was "Reserved" during the 2004 Revision, it has now been assigned the new subject matter of <u>Securities and Investment</u> and relevant Chapters are recodified under the Title.
