SHORT TITLE

1. This Act may be cited as the Nauru Island Council Subvention Act 1992.

SUBVENTION

- 2. (1) The amount of Five Hundred & Twenty One Thousand Nine Hundred Dollars (\$521,900) is, in accordance with section 84(1) of the Nauru Island Council Act, hereby granted by way of subvention to the Nauru Island Council as authorised in the Schedule to this Act.
 - (2) The amount provided by subsection (1) shall be withdrawn from the Treasury Fund and paid to the District Fund and the Treasury Fund is charged accordingly.
 - (3) The amount provided by subsection (1) may be withdrawn in such amounts and at such times before 31 December 1992 as the Minister For Finance shall approve.
