MOTOR TRAFFIC ACT 1937-1972ROAD TRAFFIC SIGNS

In exercise of the powers in that behalf conferred upon me by Section 43(1) of the Motor Traffic Act 1937-1972, I, AUSTIN BERNICKE, Acting President of the Republic of Nauru, HEREBY SPECIFY the design and meaning of the following traffic control signs:-

## (1) AIRCRAFT APPROACHING STOP SIGN:-

Design: Dual red lights in horizontal with bell system, underneath of which appears firstly, a white rectangular sign bearing the words "Aircraft Approaching" in black, and secondly, a black rectangular sign bearing the words "Stop on Red Signal" in white.

Meaning: Stop at sign when red lights are flashing alternately, and do not proceed until both red lights are extinguished.

## (2) AIRCRAFT APPROACHING BARRIER SIGN:

Design: Drop arm traffic barrier, yellow and black in colour.

Meaning: When barrier is in a horizontal position across the road, stop, and do not proceed until barrier is raised to a vertical position to the road.
