## COMMISSION

In exercise of the powers conferred on it by Section 3 of the Commissions of Inquiry Ordinance 1948-1967, the Cabinet hereby issues a Commission to the Chief Justice, the Honourable Mr. Justice Ian Roy Thompson, as the sole Commissioner to inquire into the following matter, that is to say -

whether the salaries and allowances payable to the persons holding the offices of President, Minister, Speaker, Deputy Speaker and Member of Parliament under the provisions of the Parliamentary Salaries and Allowances Act 1971 are adequate and appropriate;

And the Cabinet requires and authorises the said Commissioner to have regard in the said Inquiry to the duties and responsibilities of the respective offices and to investigate and ascertain such other facts as he considers to be relevant to the subject-matter of the said Inquiry;

And further the Cabinet requires the said Commissioner, upon completion of the said Inquiry to make it to recommendations as to the salaries and allowances which would be adequate and appropriate to be paid to the persons holding the said offices of President, Minister, Speaker, Deputy Speaker and Member of Parliament.

## PRESIDENTIAL, MINISTERIAL & PARLIAMENTARY SALARIES AND ALLOWANCES INQUIRY

As already notified in the Nauru Government Gazette, a Commission has been issued to me by the Cabinet to inquire whether the salaries and allowances at present payable to persons holding the offices of President, Minister, Speaker, Deputy Speaker and Member of Parliament are adequate and appropriate and, if not, to make recommendations as to the salaries and allowances which would be adequate and appropriate.

Any person who wishes to make any representation to me in this matter or to place before me any facts which he or she considers I should take into account in carrying out the inquiry or making recommendations is invited to do so. Representations and statements of facts may be made either in writing or verbally. If made in writing, they should be in English and should be sent or delivered to the Registrar of the Supreme Court on or before Friday, 20th September, 1974; he will then deliver them to me. Verbal representations and statements of facts may be made in English or Nauruan. Any person who wishes to make a verbal representation or statement of facts should notify the Registrar of the Supreme Court by not later than Friday, 13th September, 1974. The Registrar will then make an appointment for that person to come and see me for the purpose and will notify him or her of the time, date and place for doing so. Statements of facts should, unless self-evident, be supported by evidence establishing them.
