CONSTITUTION OF NAURUAPPOINTMENT BY CABINET UNDER ARTICLE 21

CONSTITUTION OF NAURUASSIGNMENT OF RESPONSIBILITIES UNDER ARTICLE 23

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN ME UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, AUSTIN BERNICKE, ACTING AS PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF CABINET OF NAURU AS SET OUT BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR RESPECTIVE NAMES:-

THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT OF NAURU SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, O.B.E., M.P.
