The Nauru Lands Committee's decision as to the beneficiaries of the estate of ADENGO was published in Gazette No. 48 of 1955.

Any person dissatisfied with this determination of the Nauru Lands Committee may appeal to the Supreme Court within 21 days of the publication of this notice.
