CONSTITUTION OF NAURU

APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf in it vested in it under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE AUSTIN BERNICKE, being the Minister for Health and Education and a Member ofthe Parliament of Nauru, to perform the duties and exercise the functions of the President during the period of absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P.

CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITIES UNDER ARTICLE 23
