CLASSES IN SHORTHAND AND TYPING

- Consideration is being given to conducting courses in typing and in shorthand, commencing in February, 1979. The courses will be designed for any or all of the following purposes:
- (a) Improve the speed and accuracy of those who have acquired the basic skills of typing and/or shorthand.
- (b) Teach shorthand to those who can type competently but have never learnt shorthand.
- (c) Teach typing as an aid in day-to-day work or as a general skill, rather than for full-time employment.

The following arrangements are proposed :-

- (i) Enrolment will be open to all residents of Nauru, including staff of the Public Service, N.L.G.C. and N.P.C. and people who are not in employment at all.
 - to no. i An Classes will be held at the Nauru Secondary School.
- Classes would possibly be conducted on four afternoons per week from 3.30 p.m. to 5.00 p.m. The Public Service Commissioner has decided that Public Service staff attending classes to improve their competence would be allowed time off from work to attend classes and will be given the opportunity to complete exercises during working hours when they do not have the facilities at home.
- The system of shorthand to be taught is called T-line, which is different from older types such as Pitman and Dacombs. However, the tutor may be able to arrange instruction for those who have learnt another system and want to improve their speed.
 - (v) To be able to master shorthand, a good command of English is necessary.
 - (vi) The tutor has emphasised that only persons who want tollearn should enrol. Those enrolling will be expected to given an undertkaing to attend regularly and complete all required exercises for an agreed period probably six months initially. No person will be compelled to undertake a course.
 - (vii) No fees will be payable. Text books will be lent for the course. They may be bought by those taking part: otherwise, they must be returned on completion of the course.

Those interested in enrolling should obtain an application form from the S.A.O.'s office (phone 3301). Completed forms shouldbe left at the S.A.O.'s office before 23rd December. A speed and accuracy test will be arranged for those who have learnt typing or shorthand previously to determined their standard. Similarly fluency in English wall be assessed for those wanting to do shorthand.

This opportunity is commended to all interested persons. A young Nauruan lady who returned from overseas in May without any typing or shorthand is now typing at 43 words per minute and doing T-Line

shorthand at 80 words per minute. She accomplished this through instruction received from Mrs Weatherhead. Certainly she has done a great deal of practice but anyone with a real desire to learn and prepared to practice can succeed also.
