AUDIT ACT 1973

DIRECTOR OF AUDIT (SALARY) NO. 2) REGULATIONS 1979

IN EXERCISE of the powers conferred on Cabinet by Section 3 of the Audit Act 1973 the Cabinet hereby makes the following Regulations -

TITLE

1. These Regulations may be cited as the Director of Audit (Salary) (No. 2) Regulations 1979.

SALARY OF DIRECTOR OF AUDIT

2. (1) Where the Director of Audit is a person who was not appointed under the provisions of section 18(1)(a)(iii) of the Public Service Act 1961-1975 his salary shall be whichever amount is the larger of -

(a) the amount set out in respect of salary in Part I of the Schedule to these Regulations, and

(b) the amount which is the sum of that amount and of every amount by which the basic wage of Nauruans is increased after the date on which these Regulations are made.

(2) Where the office of Director of Audit is held by a person who was appointed under section 18(1)(a)(iii) of the Public Service Act 1961-1975 his salary shall be the sum specified in Part II of the Schedule to these Regulations.

(3) In addition to his salary the Director of Audit shall be entitled to be paid and receive travel and subsistence allowances on the scale for the time being payable to Public Service heads of department.

G.N. No. 273/1979 (Cont'd)

(4) The salaries provided for by paragraphs (1) and (2) of this regulation shall have effect from the date specified in the second column of Parts I and II respectively of the Schedule to these Regulations.

REPEAL

3. The Director of Audit (Salary) Regulations 1977 and the Director of Audit (Salary) Regulations 1979 are hereby repealed.
