JUDICIAL SALARIES REGULATIONS 1980

IN EXERCISE of the powers conferred on Cabinet by section 2 of the Statutory Salaries Act 1974 the Cabinet hereby makes the following Regulations

TITLE

1. These Regulations may be cited as the Judicial Salaries Regulations 1980.

SALARY AND ALLOWANCES OF THE CHIEF JUSTICE

2. With effect from the 1st day of January 1980, the salary and allowances of the Chief Justice shall be those set out in the Schedule to these Regulations.

REPEAL

3. The Judicial Salaries Regulations 1979 are hereby repealed

SCHEDULE

SALARY AND ALLOWANCES OF THE CHIEF JUSTICE

Salary : \$15,400 per annum

Supplementary salary payable while the Chief Justice is based in Melbourne (including period of temporary absence): \$6050 per annum

Representation Allowance \$2200 per annum

In addition the Chief Justice shall be entitled to be paid such travel and subsistence allowances as are for the time being payable to public service heads of department on the same scale as such public service heads of department.
