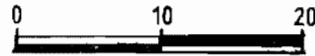

# DISTRICT OF BUADA


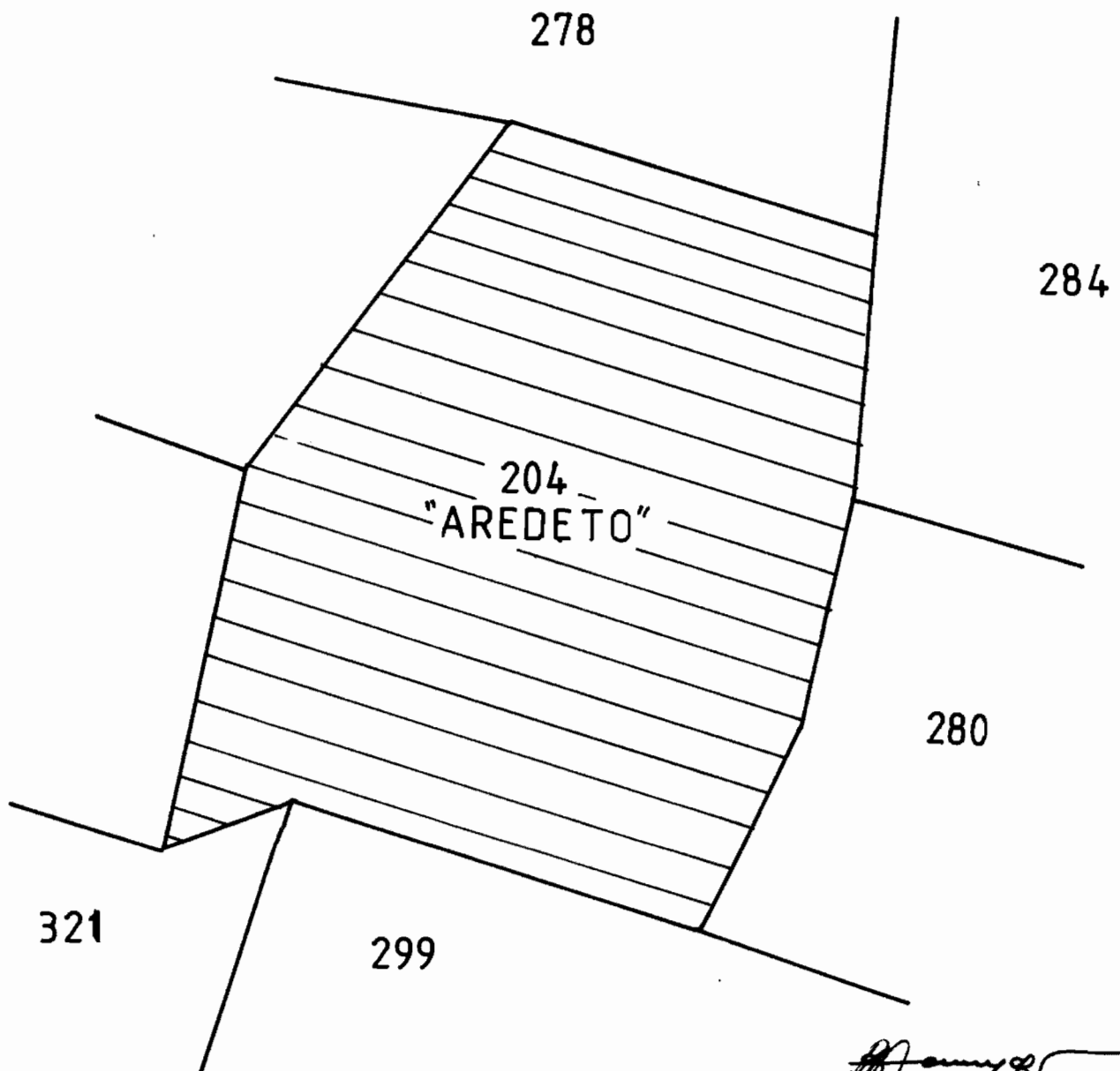

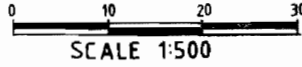
