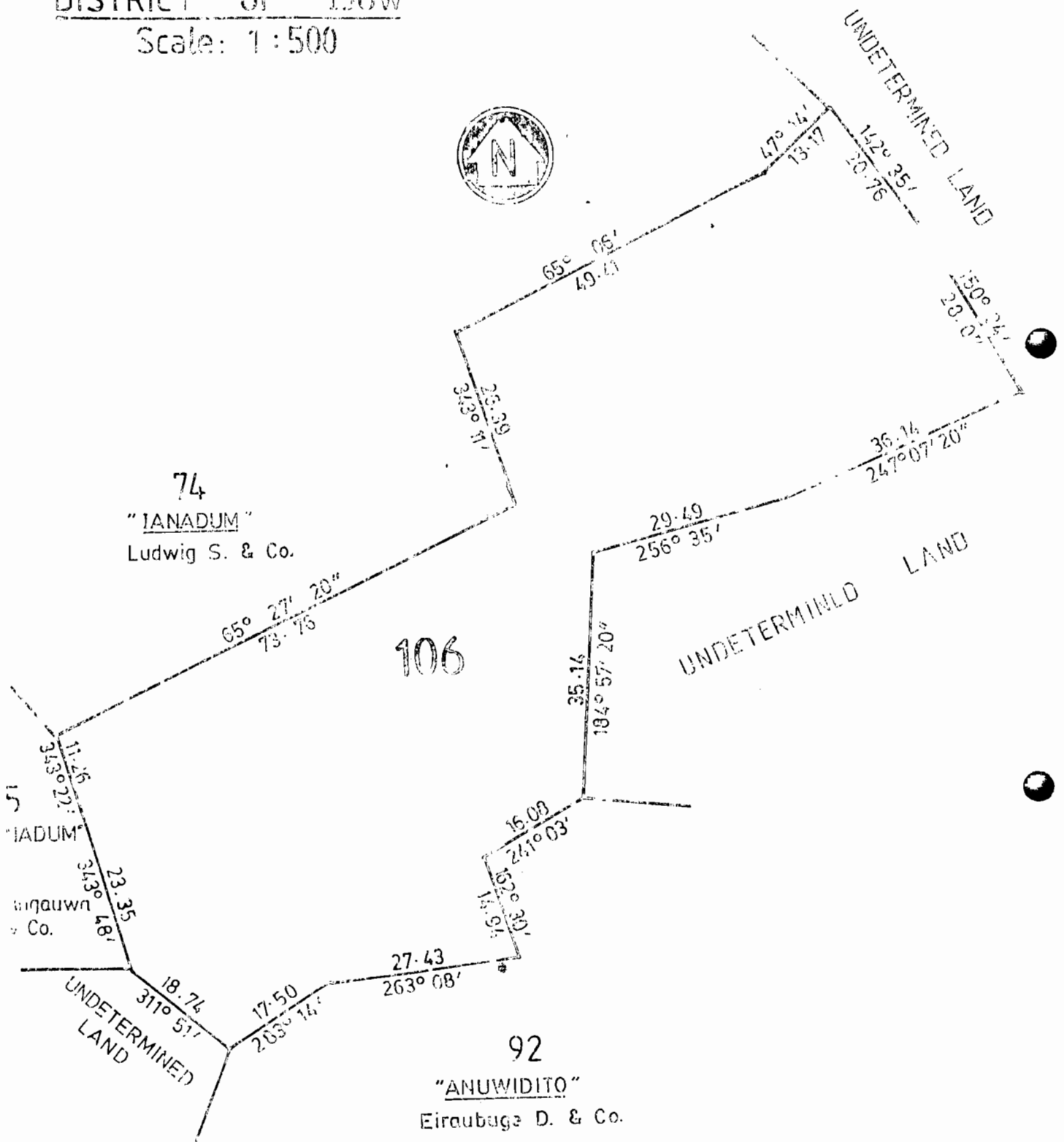

DISTRICT OF IJW

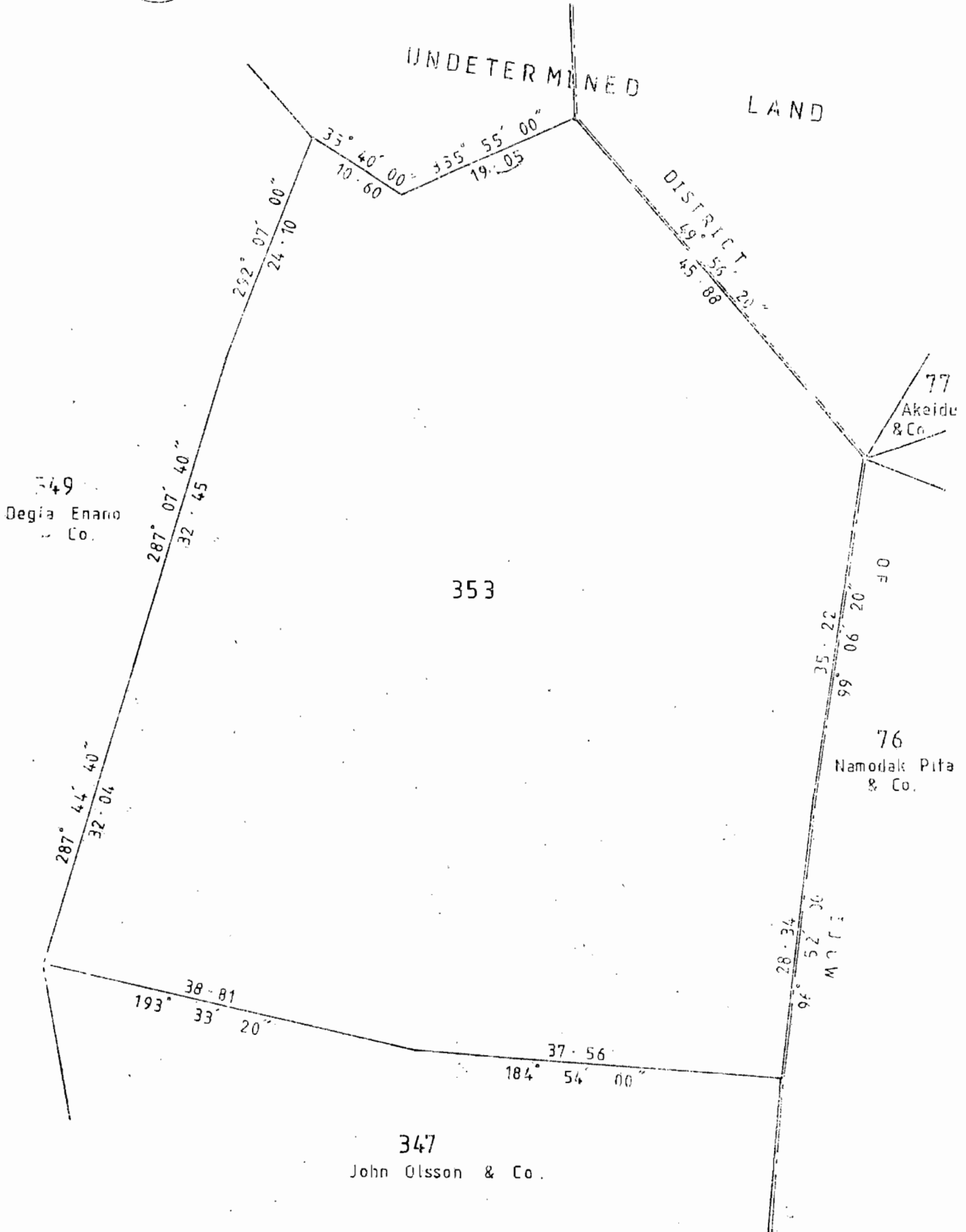
