MIGRATION ACT 1958-1973 (SECTION 40)

APPOINTMENT OF PRESCRIBED AUTHORITY

In supersession of the notification dated 2nd October 1985, I, <u>BERNARD DOWIYOGO</u>, Minister for Justice and Minister responsible for Customs and Immigration, by virtue of the powers vested in me under Section 40, sub-section (1) of the Migration Act 1958-1973 (hereinafter called as "The Act") as adopted to Nauru, <u>DO HEREBY REVOKE</u> all previous appointments to the office of the Prescribed Authority under the Act and simultaneously <u>APPOINT SUSHIL CHANDRA CHATURVEDI</u>, <u>RESIDENT</u> <u>MAGISTRATE</u>, to be the Prescribed Authority for the purposes of the Act, with effect from the 12th day of August 1987 until further notice.
