DUTIES

- : (a) Ensuring that all teaching is in accordance with the curricula and syllabus materials stipulated by the Director.
 - (b) Planning of the time-table and school supplies and supervision of the teaching and discipline within the school at his/her direction, some teaching of senior classes per week and ensuring that staff strength is utilised for maximum benefit of the pupils.
 - (c) The efficient ordering, distribution and control of supplies and equipment, and assistance with budgeting, and providing in-service guidance to teachers and student-teachers on the staff.
