APPOINTMENT OF ACTING RESIDENT MAGISTRATE

PURSUANT TO the powers in that behalf vested in me under Section 9, sub-clause (5) of the Courts Act 1972, I, VINSON DETENAMO, Acting President of the Republic of Nauru, DO HEREBY appoint Mr. BUDDHAVARAPU YERRAMA RAJU to act as Resident Magistrate with effect from the 4th day of November, Nineteen Hundred and Eighty-Nine, until further notice.

CONSTITUTION OF NAURU

ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS
OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE ACTING PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, VINSON DETENAMO, ACTING PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTER OF THE CABINET OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIS NAME:

MINISTER OF CABINET

BUSINESS OF GOVERNMENT

MINISTER FOR JUSTICE

THE PORTFOLIO OF THE MINISTER FOR FINANCE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENTS SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HONOURABLE KENNAN ADEANG, M.P., MINISTER FOR FINANCE.
