REPUBLIC OF NAURU CONSTITUTION OF NAURU CABINET APPOINTMENT UNDER ARTICLE 21

<u>IN EXERCISE OF</u> THE THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU <u>DOES HEREBY APPOINT</u> THE HONOURABLE VINSON DETENAMO, M.P. BEING THE MINISTER FOR WORKS AND COMMUNITY SERVICES AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT BERNARD DOWIYOGO, M.P. FROM THE REPUBLIC.

ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE

BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, <u>BERNARD DOWIYOGO</u>, M.P., PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-

MINISTERS OF CABINET

THE HONOURABLE VINSON DETENAMO M.P.

THE HONOURABLE KINZA CLODUMAR M.P.

THE HONOURABLE PRES NIMES EKWONA M.P.

BUSINESS OF GOVERNMENT

THE PORTFOLIOS OF THE MINISTER FOR EXTERNAL AFFAIRS, INTERNAL AFFAIRS AND PUBLIC SERVICE IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE PRESIDENT AS MINISTER.

THE PORTFOLIO OF THE MINISTER FOR HEALTH AND EDUCATION IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENTS OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE ARE IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT BERNARD DOWIYOGO, M.P. AND THE MINISTER FOR HEALTH AND EDUCATION, THE HONOURABLE VINCI CLODUMAR FROM THE REPUBLIC.
