PROVIDENT FUND ACT 1938-1990

PROVIDENT FUND (INCOME) REGULATIONS 1990

IT IS NOTIFIED for general information that Cabinet has, at its meeting held on 27th December, 1990 pursuant to Provident Fund Act 1938-1990 approved the recommendation that Cabinet make the Regulations known as Provident Fund Income Regulations 1990, as under:-

PROVIDENT FUND (INCOME) REGULATIONS 1990

CITATION

1. These Regulations may be cited as the Provident Fund (Income) Regulations 1990.

INTERPRETATION

- 2.(1) In these Regulations unless the context otherwise requires:
"Income" means the sum Found to be the total of undistributed accumulated interest income of the Fund as at 30th Day of June every financial year.
- (2) Words and phrases used herein unless the context otherwise requires have the same meaning as in the Act.

DISTRIBUTION OF INCOME

- 3.(1) Income available as on 30th June, 1987 shall be distributed at 25% rate based on members' balance as on 30th June, 1987.
- (2) Income available as on 30th June, 1988 shall be distributed at 9% rate based on members' balance as on 30th June, 1988.
- (3) Income available as on 30th June, 1989 shall be distributed at 9% rate based on members' balance as on 30 th June, 1989.
- (4) Income available as on 30th June, 1990 shall be distributed at 9% rate based on members' balance as on 30th June, 1990.
4. In the event of a member discontinuing the membership before the qualifying period at the relevant time, the income in respect of his own contribution shall be paid to him and the income in respect of the Government contribution shall be paid to the Republic. Income in respect of the members who have not completed the qualifying period shall be credited into their respective accounts.

FIXATION OF RATE OF INTEREST

5. With effect from 1st July, 1990, interest shall be based on contributions to "A" and "B" accounts at the prevalent Bank of Nauru rate of Interest on 7-Day Call account less 1% ruling on the first day of the month.
