NAURU ISLAND COUNCIL ACT 1992

FIRST ELECTIONS 1992

IN EXERCISE of the powers conferred upon it by Section 24 of the Nauru Island Council Act 1992 (hereafter referred to as the Act) Cabinet HEREBY MAKE the following Orders.

1. The first Nauru Island Council elections shall be conducted by MR NIKHIL CHANDRA who shall exercise all of the powers of the returning officer set forth in Schedules 2 and 3 of the Act.
2. He shall carry out the responsibilities of the Secretary described in Section 11.
3. He shall prepare and certify the preparation of the voters roll as required by Section 12.

NOTICE is hereby given that an election for the Nauru Island Council is to be held on Saturday the 2nd May, 1992.

VOTERS ROLLS

All person aged 20 years or over are entitled to apply to be enrolled.

A person who was enrolled in respect of the elections for the Nauru Local Government Council elections in November, 1991 is not required to make application to be enrolled unless he or she has changed his or her residence and wishes to be enrolled in respect of a different District.

Persons who wish to enroll for the first time or to change their district of enrollment may make application on the prescribed form which may be obtained from the office of the Returning Officer during normal working hours. The rolls will be opened on Thursday, 2nd April, 1992 and closed on Friday, 10th April, 1992.

Voting is compulsory.

Enrollment forms must be lodged at the office of the Returning Officer no later than 4.00pm, on Friday, 10th April, 1992.

CANDIDATES

Any person wishing to nominate as a candidate for the elections may lodged notice of candidature at the office of the Returning Officer from Monday, 13th April, 1992 but no later than 12.00 noon on Saturday, 18th April, 1992.

Notices of Candidature are available at the office of the Returning Officer.

Withdrawal of candidature may be effected before 4.00pm., on Saturday, 18th April, 1992.

HOURS OF VOTING

Voting shall commence at 1.00pm., and conclude at 6.00pm.

IN EXERCISE of the powers conferred upon it by section 95 of the Nauru Island Council Act 1992 Cabinet has made the following regulations:

TITLE

1. These regulations may be referred to as the Nauru Island Council (Forms) Regulations 1992

APPLICATION FOR ENROLLMENT

2. A person wishing to enroll for a district, or to change his or her enrollment shall complete and sign an application for enrollment in the form of the First Schedule.

NOMINATION OF CANDIDATES

3. A person wishing to nominate as a candidate for election shall complete a notice of candidature in the form of the Second Schedule

VOTING AND BALLOT PAPERS

4(1) In order to be valid a ballot paper must be marked by a voter placing a number against the name of each candidate in the order of the voter's preference.

(2) A voting paper shall not be invalid merely because the numbers placed on the paper are not consecutive.

(3) A voting paper shall be valid if numbers are placed against the name of each candidate but one which shall be deemed to be the voter's last preference.

(4) Ballot papers shall be in the form of the Third Schedule
