APPOINTMENT OF CHAIRMAN AND MEMBERS OF THE NAURU PHOSPHATE ROYALTIES TRUST

It is notified for general information that the Cabinet, at its meeting held on Thursday, 23rd April, 1992, has

- 1. Approved shifting of the Principal Office of the Nauru Phosphate Royalties Trust from Melbourne to Nauru with effect from 1st May, 1992; and to maintain a skeleton office of the Trust at Melbourne so as to:-
- i) Implement the decisions of the Trust members taken at Nauru in the matter of investment of the moneys lying in the various Funds of the Trust and the disposition thereof.
- ii) Furnish feed back on market intelligence reports relating to the movement of securities traded on stock exchanges of various countries or otherwise.
- iii) Monitor the investments made by the Trust in securities Real Estates, in accordance with the decisions taken by the Trust from time to time.
 - iv) Make recommendations to the Trust office on Nauru as may be considered necessary and helpful by the Trust members for taking decisions on the investments to be made from the moneys available in the Funds for such investments or for disposal of such investments for capital gains and for other purposes or otherwise.
 - 2. Pursuant to Section 7 subsection (1) of the Nauru Phosphate Royalties Trust Ordinance 1968, terminated the appointment of the following with effect from 30th April, 1992:
 - a) Mr. T.C. Moses, Member and Chairman;
 - b) Mr. A. Moore, Member
 - c) Mr. D.A.Morgan, Member
 - 3. Pursuant to Section 5, subsection (1), clause (b) of the Trust Ordinance, appointment the Honourable Rueben Kun, as required by Section 8, subsection (1) of the Trust Ordinance to be a member of the Trust with effect from 1st May, 1992 until 30th April, 1995.




