#### DUTIES

You will be responsible to the Director of Medical Services through the Executive Officer for day-to-day running of the Pharmacy and for the following:

- (a) issuing of ready made Pharmaceutical supplies as prescribed by Medical Officers;
- (b) stocking of Pharmaceutical goods with the regular work per out-patient and in-patient, including compounding of prescription for same;
- (c) preparation of Purchase Order for the desired drugs for submission to the Director of Medical Services;
- (d) supervision and training of one assistant;
- (e) submission of quarterly report of dangerous drugs;
- (f) recording and control of regulated dangerous drugs and
- (g) such other duties as may be directed.
