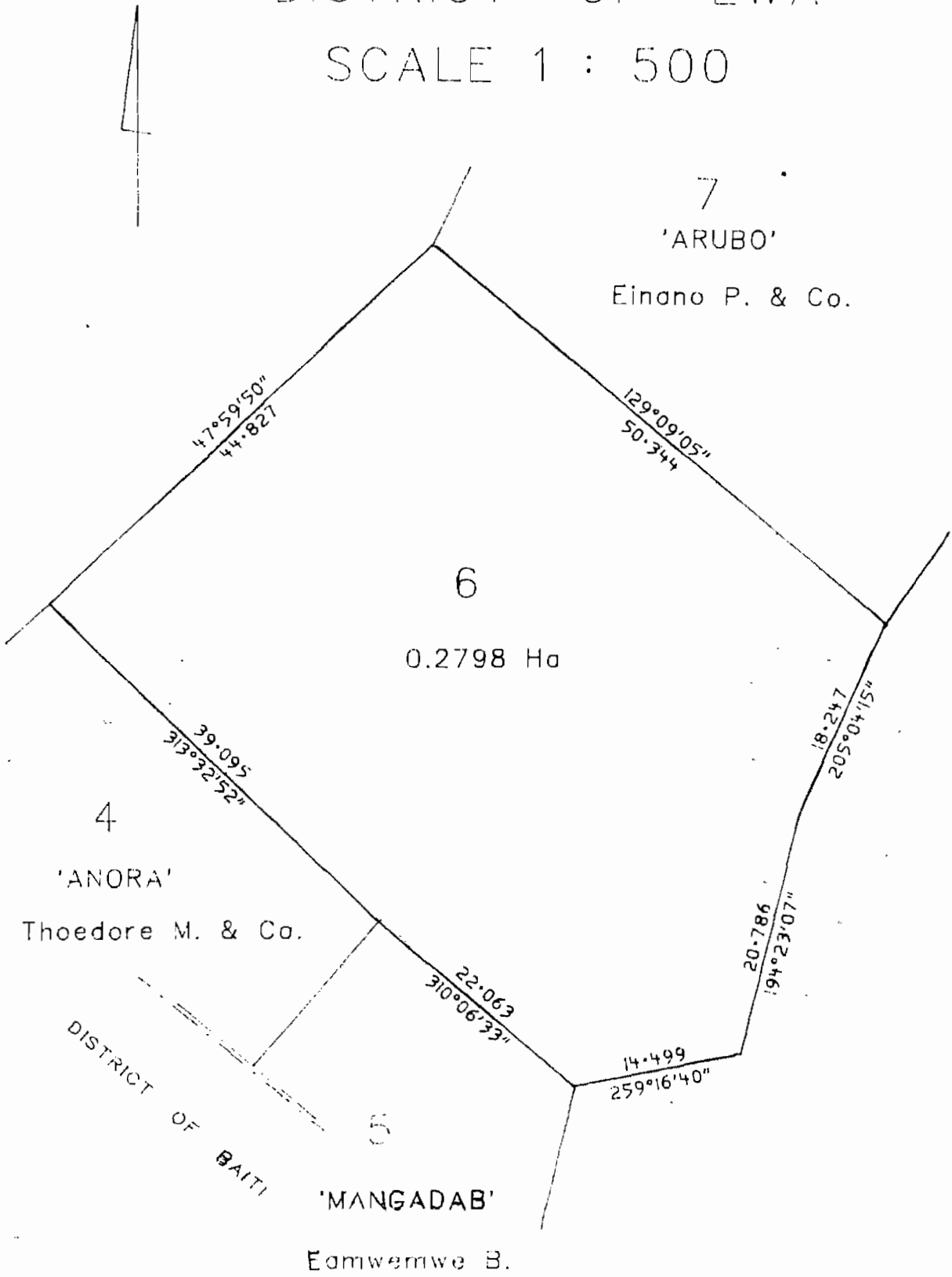

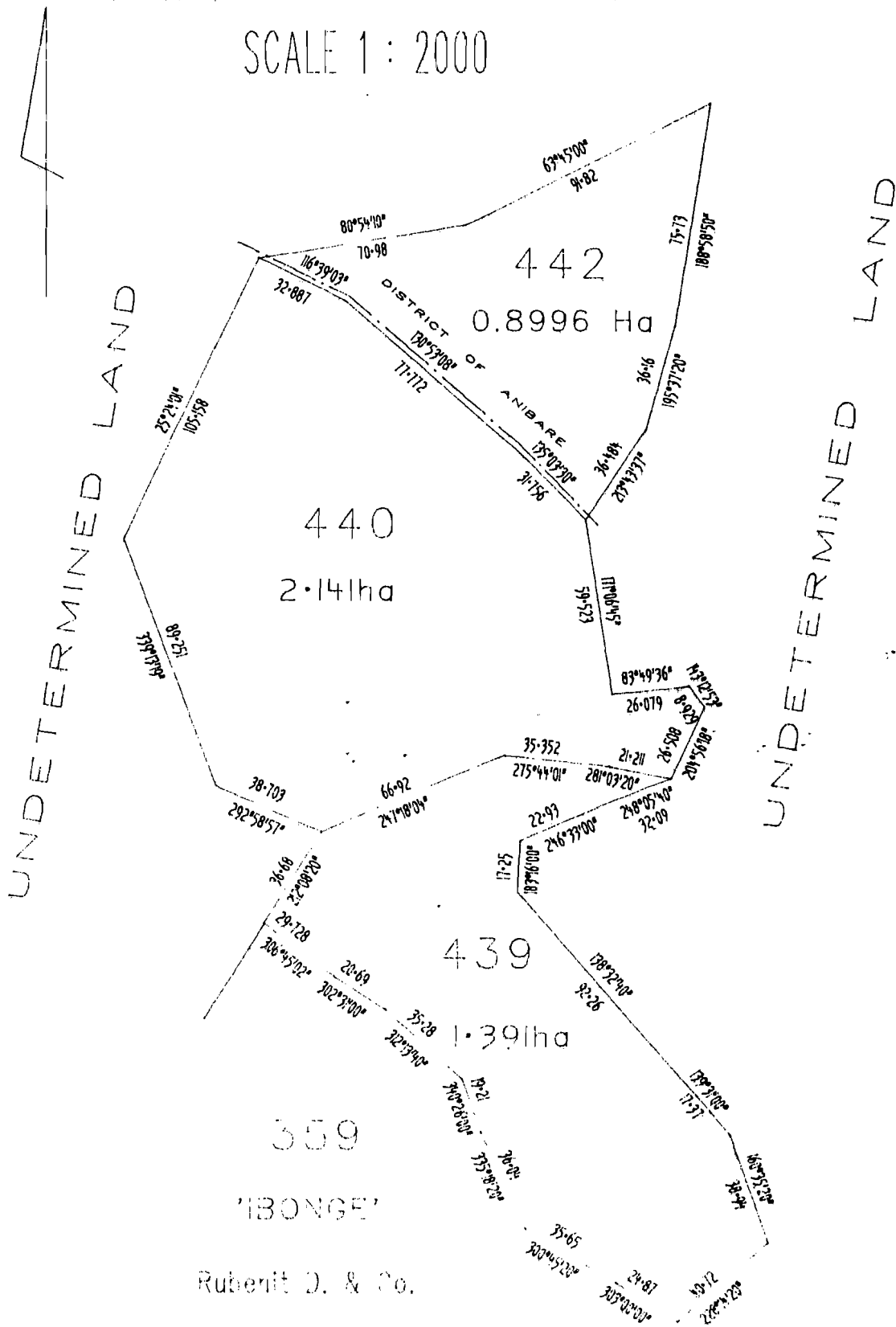
# DISTRICT OF EWA
