PUBLIC MONIES ORDINANCE 1968

FORMATION OF THE NACOS TRUST FUND

Whereas the Cabinet approved the formation of a trust called the "NACOS TRUST FUND" with the moneys received from Australia as a result of the Agreement dated 10th August, 1993 between Nauru and Australia (NACOS) whereby the proceedings instituted by Nauru in the International Court of Justice were agreed to be withdrawn with payment by Australia of A\$107 Million to be paid in instalment. The Minister for Finance in exercise of the powers vested in him under Section 9 of the Public Moneys Ordinance, 1968 hereby makes the following rules:

- The Minister for Finance does hereby create the trust fund called "NACOS TRUST FUND" with immediate effect.
- All moneys received from Australia in pursuance of the NACOS agreement shall be deposited into the NACOS Fund, in a interest bearing account with Bank of Nauru.
- 3. Moneys standing to the credit of the NACOS TRUST FUND, shall be expended only for the purposes of the rehabilitation of the mined-out phosphate lands in Nauru.
- 4. The Cabinet shall be Trustee of the NACOS TRUST FUND and shall be responsible for the administration of the fund.
- 5. The NACOS Trust Fund Bank account will be jointly operated by His Excellency The President and the Minister for Finance or other Ministers for the time being acting as President and/or Minister for Finance for and on behalf of the Trustees.
- 6. The Minister for Finance without prejudice to the generality of the foregoing provisions, may make regulations for the proper administration of the "FUND".
