### CONSTITUTION OF NAURU

## CABINET APPOINTMENT UNDER ARTICLE 21

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE VINSON DETENAMO, M.P., BEING THE MINISTER FOR FINANCE, MINISTER ASSISTING THE PRESIDENT, AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT BERNARD DOWIYOGO, M.P., FROM THE REPUBLIC.

ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE

BUSINESS OF GOVERNMENT
