RULES MADE BY THE SPEAKER UNDER SECTION 30 OF THE PARLIAMENTARY POWERS, PRIVILEGES AND IMMUNITIES ACT 1976

In Exercise of the powers conferred upon me by virtue of Section 30 of the Parliamentary Powers, Privileges and Immunities Act 1976, I hereby make the following Rules:-

- 1. These rules may be called the Parliamentary Powers, Privileges and Immunities (Issue of Summons) Rules 2002 and shall come into force with immediate effect.
- 2. The Rules set out in the Schedule as forms A to D shall be used in proceedings before the Parliament and other Parliamentary Committees including Select Committees (as the case may be).
