ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE REMY NAMADUK, M.P., BEING THE MINISTER ASSISTING THE PRESIDENT, EDUCATION, TELECOMMUNICATION, TRANSPORT AND ECONOMIC DEVELOPMENT AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY THE PRESIDENT, THE HONOURABLE RENE R. HARRIS, M.P., FROM THE REPUBLIC.
