**LEGAL PRACTITIONERS ACT 1973**  
**PLEADERS (TRAINING AND EXAMINATIONS) RULES 2004**

In exercise of the powers conferred on me by section 57 of the Legal Practitioners Act 1973-1974, I hereby make the following Rules.

**TITLE**

1. These Rules may be cited as the Pleadings (Training and Examinations) Rules 2004.

**REPEAL**

2. All previous rules and amendments relating to the Training and Examinations of Pleadings including an order under section 11(b) of the Act made 15 March 1995, are hereby repealed.

**QUALIFICATION OF PLEADER**

3. To qualify to make an application to be admitted as a pleader before the Courts of Nauru a person shall have been granted from the University of the South Pacific-

(a) A Certificate in Law (Criminal)

&

(b) A Certificate in Law (Civil).
