EXCISE EXEMPTION FOR FUEL AND EQUIPMENTS IMPORTS BY RONPHOS AND
NAURU REHABILITATION CORPORATION

It is notified for general information that Cabinet approved the Customs Tariff (Exemption) Regulations 2008 pursuant to the Customs Tariff Act 1997-2006.

1. exempt from customs duty petrol and diesel brought into Nauru by RONPHOS or NRC for their own consumption; and
2. reduce the rate of duty on imports by RONPHOS and NRC of machinery and vehicles from the current rate of 25 per cent to the normal customs duty rate of 7 per cent where the goods are not for the purposes of re-sale. This reduction in duty will apply only until 30th June, 2008, when the duty rate will return to 25 per cent for imports of machinery and vehicles.

**CENTRALIZING GOVERNMENT INFORMATION, COMMUNICATION &
TECHNOLOGY (ICT) ASSETS UNDER THE DEPARTMENT OF
INFORMATION, COMMUNICATION & TECHNOLOGY (ICT)**
