#### **SCHEDULE**

### REGISTRATION AND TRANSFER OF VOTERS NOTIFICATION

The following key can be used to identify the reason of transfer or registration of each voter.

- 1. The Roll for the District in which he or she is currently living and has been living for not less than one month; or
- 2. If he or she is living outside Nauru, the District in which he or she had been living for not less than one month immediately before he or she ceased to live in Nauru; or
- 3. The Roll for the District that is entered in the Register of Births maintained under Section 6(a) and Section 104 of the *Births, Deaths and Marriages Act 2017*; or
- 4. In any register or record of births certified under Section 9 of the *Births, Deaths and Marriages Act 2017* as his or her place of birth; or

The Roll in respect of a District with which the Electoral Commissioner has certified in accordance with Schedule 3 that he or she has substantial connection through:

- 5. Nauruan custom, customary links and affiliation;
- 6. Birth by either his or her parent in that District;
- 7. The registration for any electoral purposes of either his or her parent in that District;
- 8. His or her spouse being born in that District.
