### **ADMINISTRATIVE ARRANGEMENTS ORDER 2022**

\_\_\_\_\_

### SL No. 31 of 2022

I, Hon. Russ Joseph Kun, M.P., President of the Republic of Nauru, pursuant to Section 4(1) of the Administrative Arrangements Act 2011, make the following Administrative Arrangements Order with effect from 29th September 2022:

- 1. Each Minister specified in Column 1 of the Schedule to this Order is responsible for the administration of the written law or part of the written law specified opposite in Column 3 of the Schedule.
- 2. Each Department or part of a Department specified in Column 2 of the Schedule is responsible to the Minister specified opposite in Column 1 for the administration of the law or part of the written law specified opposite in Column 3.
- 3. Each Deputy Minister assigned responsibilities under the Deputy Ministers Act 2019 by the President or a Minister is responsible for the administration of the written law or part of a written law specified in column 3 of the Schedule.
- 4. This Order supersedes the Administrative Arrangements Order of 2020 SL No.1 of 2020.
