The Cabinet makes the following Regulations under Section 34 of the *Counter Terrorism and Transnational Organised Crime Act 2004*:

1 Citation

These Regulations may be cited as the Counter Terrorism and Transnational Organised Crime (Amendment of the Schedule) Regulations 2023.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Amendment of Schedule of the Counter Terrorism and Transnational organised Crime Act 2004

These Regulations amend the Schedule to the *Counter Terrorism and Transnational Organised Crime Act* 2004.

4 Amendment of Schedule

The Schedule to the *Counter Terrorism and Transnational Organised Crime Act 2004* is amended by inserting the following items into the Schedule after item 19:
