# NOTICE MADE PURSUANT TO REGULATION 15 OF THE CUSTOMS (IMPORT LICENSING) REGULA-TIONS EXCEPTING CERTAIN GOODS FROM THE APPLICATION OF THE REGULATIONS.

### NOTICE.<sup>(1)</sup>

## CUSTOMS (IMPORT LICENSING) REGULATIONS.

I, JACK KEITH MURRAY, Administrator of the Territory of Papua and New Guinea, by virtue of the powers conferred by Regulation 15 of the Customs (Import Licensing) Regulations, hereby except from the application of the said regulations the goods or classes of goods enumerated in the Schedule hereto.

In the Schedule hereto, the words "Customs Tariff" mean, in relation to goods imported into the Territory of Papua the Customs Tariff 1934-1950 of the Territory of Papua, and in relation to goods imported into the Territory of New Guinea the Customs Tariff Ordinance 1933-1950 of the Territory of New Guinea.

#### THE SCHEDULE.

(1) Passengers' personal effects and passengers' furniture and household goods admissible under Item 59 of the Customs Tariff.

(2) Goods being passengers' bona fide baggage admissible under Item 59 of the Customs Tariff.

(3) Goods being bona fide passengers' baggage as provided for by Regulation 22 of the Customs Regulations, provided that such goods are the passengers' personal property and are not intended for purposes of sale or trade, viz.:--

Spirituous liquors, whether such liquors are admissible under Item 59 of the Customs Tariff or not, the total quantity of which does not exceed 2 gallons;

Cigarettes, cigars and tobacco, whether such goods are admissible under Item 59 of the Customs Tariff or not, the total weight of which does not exceed 5 lb. in weight (for the purposes of this exception 400 cigarettes are to be regarded as weighing 1 lb.); and

are to be regarded as weighing 1 lb.); and Unexposed cinematograph film, not being film admissible under Item 59 of the Customs Tariff, the total quantity of which does not exceed 6,000 lineal feet, or such further quantity as the Chief Collector of Customs may allow.

(4) Motor cars owned by and in the possession of passengers prior to departure for the Territory, and introduced solely for their own use and not for purposes of sale or trade.

(5) Goods not being related to any commercial transaction sent by an individual to an individual through the Post Office.

(6) Goods which the Chief Collector of Customs is satisfied are bona fide gifts not imported for commercial purposes, the value of which in the Territory does not exceed £20, or such further amount as the Administrator may approve in special circumstances.

(7) Goods which are proved to the satisfaction of the Collector of Customs to have no commercial value.

(8) Goods which the Collector of Customs is satisfied are bona fide samples, not being goods of the kind for which import licences are not normally granted.

(9) Trade catalogues, price lists and like printed matter admissible under Item 61 of the Customs Tariff.

(10) Trophies won abroad and Decorations, Medallions and Certificates awarded or to be awarded and sent from abroad for presentation or competition in the Territory when admissible under Item 68 of the Customs Tariff.

(11) Re-imported goods which are admissible under Items 23 and 27 of the Customs Tariff.

(12) Books (not being periodicals or magazines) relating to scientific and technical subjects and such other books as may from time to time be approved by the Collector of Customs, when consigned to or addressed to such public libraries or other reference libraries as are approved or specified by the Administrator.

(13) Outside packages and outer coverings admissible under Item 57 of the Customs Tariff when containing solely goods which are excepted from the application of the said regulations.

(14) Goods produced manufactured or purchased in and consigned to the Territory from the Commonwealth of Australia and from the British Solomon Islands Protectorate, Cook Island, Fiji, Gilbert and Ellice Islands Colony, Nauru, New Caledonia, New Hebrides, New Zealand, Norfolk Island, Pitcairn Island, Portuguese Timor, Society Islands, Tonga and Western Samoa.

(15) Goods produced manufactured or purchased in and consigned to the. Territory from the United Kingdom.

(16) Goods produced or manufactured in and consigned to the Territory from-

British Borneo, i.e., Brunei, North Borneo (including Labuan) and Sarawak.
