TERRITORY OF PAPUA AND NEW GUINEA.

Native Labour Ordinance 1946.

IN pursuance of the powers conferred by section 22 (1) of the Native Labour Ordinance 1946, I, John Breen McKenna, the Acting Director, Department of Native Labour, do hereby prohibit until further notice the recruitment or engagement in any area, excluding the Central Highlands District, having an altitude of not less than 3,500 feet above sea level of any native for any employment in or removal to or from any area having an altitude of not less than 3,500 feet above sea level without my written permission having been first obtained in that behalf:

Provided that labourers from the Central Highlands District may be employed in any part of the Territory of Papua and New Guinea subject to the following conditions:—

- 1. The labourer has been vaccinated as required by the Director of Public Health.
- 2. He will be employed only at a centre where a medical practitioner or medical assistant acceptable in writing to the Director of Public Health is stationed.
- 3. The vaccination process commenced in the Central Highlands will be completed by the medical practitioner or medical assistant mentioned above.
- 4. Each native will receive regularly and without fail one tablet of Paludrine three times weekly.
- 5. Supplies of Penicillin will be kept at the centre of employment of Highland labour, to be used immediately on any sign of respiratory disease.
- 6. Failure in any instance to fulfil these requirements will cause immediate cancellation of the contract and repatriation to an approved health centre at employer's expense.
- 7. The native labourer will be returned to an approved health centre in the Central Highlands on the termination of his contract by the employer, whose responsibility will then cease.
- 8. Any abnormal disease or sickness amongst these labourers will be immediately reported in writing to the Director of Public Health, or in the case of a death or if the sickness is undiagnosed or is a gazetted infectious case, it will be reported by radiogram.

The recruiting of native labourers in the Central Highlands District shall only be effected by Officers of the Administration.

Employers desirous of employing labourers from the Central Highlands District, subject to the conditions contained herein, are required to advise the Director of Native Labour as to the labour required.

PART D: NATIVES-

On the completion of the immunization required, recruits will be advised of the employment available, and, if such employment is acceptable to the recruit the employer will be informed so that the necessary arrangements may be made by him to complete a contract and arrange movement accordingly.

The labourer shall be deemed to be recruited as from the date notified to the employer that he will be available for employment and if the labourer is not transported to his place of employment on this date the employer will be responsible for the labourer's maintenance until such time as the contract has been completed.

The employer shall return the labourer upon termination of the engagement under the contract to the Health Centre endorsed on the said contract.
