ORDINANCES REVISION ORDINANCE (No. 2) 1951.(1)

No. 20 of 1952.

An Ordinance to amend certain Ordinances and other Laws in Force in the Territory.

B E it ordained by the Legislative Council for the Territory of Papua and New Guinea in pursuance of the powers conferred by the Papua and New Guinea Act 1949-1950, as follows:—

Short title.

1. This Ordinance may be cited as the Ordinances Revision Ordinance (No. 2) 1951.

Commencement.

2. This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.

Amendment of Ordinances of the Territory of Papua. 3. The Ordinances of the Territory of Papua specified in the first column of the First Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Amendment of Regulations of the Territory of Papua-New Guinea. 4. The Regulations of the Territory of Papua-New Guinea specified in the first column of the Second Schedule to this Ordinance are amended as specified in the second column of that Schedule.

Amendment of Ordinances of the Territory of Papua and New Guinea. 5. The Ordinances of the Territory of Papua and New Guinea specified in the first column of the Third Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Citation of The Courts and Laws Adopting Ordinance (Amended) of 1889 (Papua). 6. The Courts and Laws Adopting Ordinance (Amended) of 1889 of the Territory of Papua, as amended before the commencement of this Ordinance, may be cited as the Courts and Laws Adopting Ordinance 1889-1951.

Citation of amended Ordinances. 7. Each Ordinance specified in the first column of the Fourth Schedule to this Ordinance, as amended by this Ordinance, may be cited in the manner specified in the second column of that Schedule opposite the reference to that first-mentioned Ordinance in the first column.
