Public Service Ordinances 1949.

EXEMPT OFFICERS, APPOINTED AS OFFICERS UNDER SECTION 30 OF THE "PAPUA AND NEW GUINEA ACT 1949".

Pursuant to the provisions of section five of the Public Service Ordinances 1949 of the Territory of Papua and New Guinea, I hereby declare that on and after the 1st July, 1949, the provisions of the Public Service Ordinances 1949 (except where the contrary intention appears) shall not apply to the following Officers and classes of officers of the Territory of Papua and New Guinea:—

- 1. The Public Service Commissioner of the Territory;**

2. All persons appointed, for specified periods, as Officers of the Public Service of the Territory, in pursuance of section thirty of the Papua and New Guinea Act 1949; and

3. All persons appointed as Officers of the Public Service of the Territory in pursuance of section thirty of the Papua and New Guinea Act 1949, who are remunerated by fees, allowances or commission only.

Public Service Ordinance 1949-1950.

EXEMPT OFFICERS.

Appointed as Officers under section 30 of the *Papua and New Guinea Act 1949-1950*.

Pursuant to the provisions of section five of the *Public Service Ordinance 1949-1950* of the Territory of Papua and New Guinea, I hereby declare that on and after the 9th November, 1950, the provisions of the *Public Service Ordinance 1949-1950* (except where the contrary intention appears) shall not apply to the following Officers and classes of Officers or employee or class of employees of the Territory of Papua and New Guinea:—

1. The Public Service Commissioner of the Territory;

2. All persons appointed, for specified periods, as Officers of the Public Service of the Territory, in pursuance of section thirty of the *Papua and New Guinea Act 1949-1950*; and

3. All persons appointed as Officers of the Public Service of the Territory in pursuance of section thirty of the *Papua and New Guinea Act 1949-1950*, who are remunerated by fees, allowances or commission only.
