PUBLIC SERVICE ORDINANCES REPEAL ORDINANCE 1950.(1)(2)

No. 40 of 1950.

An Ordinance to repeal the Public Service Ordinances of the Territory of Papua and the Public Service Ordinances of the Territory of New Guinea.

B E it ordained by the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Papua and New Guinea Act 1949, as follows:—

- 1. This Ordinance may be cited as the Public Service Ordinances short title. Repeal Ordinance 1950. (1)(2)
- 2. This Ordinance shall be deemed to have come into operation commencement. on the first day of July, One thousand nine hundred and fortynine.
- 3. The Ordinances specified in the Schedule to this Ordinance Repeal are repealed.
