WEIGHTS AND MEASURES—

WEIGHTS AND MEASURES (NEW GUINEA) ORDINANCE 1950.⁽¹⁾⁽²⁾

No. 47 of 1950.

An Ordinance to make provision for bringing into operation the Weights and Measures Ordinance 1939 of the Territory of New Guinea, and for other purposes.

B^E it ordained by the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Papua and New Guinea Act 1949, as follows:—

Short title.

1. This Ordinance may be cited as the Weights and Measures (New Guinea) Ordinance 1950.⁽¹⁾⁽²⁾

Commencement.

2.—(1.) Subject to this section, this Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.⁽¹⁾

(2.) Section four of this Ordinance shall not come into operation until the date fixed under section two of the Weights and Measures Ordinance 1939⁽³⁾ of the Territory of New Guinea for the operation of the provisions of that Ordinance.

3.—(1.) The Weights and Measures Ordinance 1939⁽³⁾ of the Territory of New Guinea shall, by force of this Ordinance, but subject to the next succeeding sub-section, be deemed to be in force in the Territory of New Guinea.

(2.) The provisions of the Ordinance referred to in the last preceding sub-section shall not operate until the date fixed under section two of that Ordinance.

4.-(1.) The Laws Repeal and Adopting Ordinance 1921- Amendment of 1939⁽⁴⁾ of the Territory of New Guinea is amended by omitting from and Adopting the Third Schedule thereto the words and figures "Weights and Ordinance 1921-1939. Measures Ordinance 1913".

(2.) The Laws Repeal and Adopting Ordinance 1921-1939⁽⁴⁾ of the Territory of New Guinea, as amended by this Ordinance, may be cited as the Laws Repeal and Adopting Ordinance 1921-1950.

5. Section three of the Laws Repeal and Adopting Ordinance Amendment of 1939⁽⁵⁾ is repealed.
