# Criminal Code (Amendment) Act 1993,

Being an Act to amend the *Criminal Code* (Chapter 262),

MADE by the National Parliament.

- 1. FALSE STATEMENTS REQUIRED TO BE UNDER OATH OR SOLEMN DECLARATION (AMENDMENT OF SECTION 196).

  Section 196(3) of the *Criminal Code* is repealed.
- 2. ESCAPE BY PRISONER (AMENDMENT OF SECTION 139). Section 139 of the Criminal Code is amended by repealing the penalty clause and replacing it with the following:-"Penalty: A term of imprisonment of not less than five years.".
- 3. UNNATURAL OFFENCES (AMENDMENT OF SECTION 210).
  Section 210(3) of the *Criminal Code* is repealed.
- 4. ATTEMPTS TO ABUSE GIRLS UNDER 10 (AMENDMENT OF SECTION 215). Section 215(2) of the *Criminal Code* is repealed.
- 5. OBTAINING GOODS OR CREDIT BY FALSE PRETENCE OR WILFULLY FALSE PROMISE (AMENDMENT OF SECTION 404).

  Section 404(4) of the *Criminal Code* is repealed.
- 6. OBTAINING EXECUTION OF VALUABLE SECURITY BY FALSE PRETENCE OR WILFULLY FALSE PROMISE (AMENDMENT OF SECTION 405). Section 405(2) of the *Criminal Code* is repealed.
- 7. CONSPIRACY TO DEFRAUD (AMENDMENT OF SECTION 407).
  Section 407(2) of the *Criminal Code* is repealed.
- 8. DIRECTORS AND OFFICERS OF CORPORATIONS FRAUDULENTLY APPROPRIATING PROPERTY, KEEPING FRAUDULENT ACCOUNTS OR FALSIFYING BOOKS OR ACCOUNTS (AMENDMENT OF SECTION 414).

  Section 414(2) of the *Criminal Code* is repealed.
