# 1. INTERPRETATION (AMENDMENT OF SECTION 1).

Section 1 of the Principal Act is amended by inserting after the definition of "The Safety Officer" the following definition:-

"the STCW Convention" means the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers 1978, as affected by any amendment made under Article XII of the said Convention.".

#### 2. PART V - CREWMEN (AMENDMENT OF PART V).

Part V of the Principal Act is amended by adding at the end of that Part the following new Division:-

" Division 8. - International Maritime Conventions.

#### 163A. CONVENTION TO HAVE EFFECT.

- (1) Subject to this Act and any other law, the STCW Convention shall have the force of law.
- (2) Where, in respect of a ship that is registered under this Act, there is a failure to comply with a requirement of the STCW Convention, the master or owner of the ship is guilty of an offence.

Penalty: A fine not exceeding K1,000.00.

Default Penalty: A fine not exceeding K50.00.

# 163B. IMPLEMENTATION OF CONVENTION.

(1) The regulations may make provision for, or in relation to, the implementation of, or giving effect to, the STCW Convention.
