- 1. INTERPRETATION (AMENDMENT OF SECTION 1).
- Section 1(1) of the Principal Act is amended by repealing the definitions of "Police Appeal Tribunal" and "the Police Appeal Tribunal".
- PENALTIES (AMENDMENT OF SECTION 45).
 Section 45 of the Principal Act is amended by repealing Subsections
 (4) and (5).
- 3. DEALING WITH SERIOUS OFFENCES (AMENDMENT OF SECTION 46).

 Section 46(5) of the Principal Act is repealed and is replaced with the following:-
 - "(5) The Commissioner shall notify a member of a punishment imposed on him or a recommendation made concerning him under Subsection (4).".
