Being an Act to grant and appropriate out of the Consolidated Revenue Fund a further additional sum for expenditure for the year ending 31 December 2014 and to appropriate that sum, as well as reduce the appropriations contained in the *Appropriation (General Public Service Expenditure* 2014) Act 2013,

MADE by the National Parliament.

PART I. - 2014 SUPPLEMENTARY BUDGET.

1. GRANT OF K82,000,000.

Subject to authorization from the Minister, the Secretary for Treasury may issue out of the Consolidated Revenue Fund and apply for additional expenditure of the Judiciary for the year ending 31 December 2014 the sum of K82,000,000.

2. APPROPRIATION.

Sums granted by this Act out of the Consolidated Revenue Fund for additional expenditure for the financial year ending 31 December 2014 are appropriated for the operational expenditure of the Agency identified in Schedule 1 of this Act.

3. DIRECTION FOR ADDITIONAL EXPENDITURE.

K82,000,000 must be immediately transferred to Judiciary Services for the approved purposes expressed in Section 2.

PART II. - REDUCTION OF 2014 APPROPRIATION.

4. **REDUCTION OF APPROPRIATION - OPERATIONAL.**

The *Appropriation (General Public Service Expenditure* 2014) *Act* 2013 is amended to reduce the appropriation of the Judiciary Services Infrastructure Development by K20,000,000 and the Secretary's Advance by K62,000,000 in the Treasury and Finance Miscellaneous Division, in accordance with the details set out in Schedule 2.
