## [Proclamation dated 28th December, 1925, and published in Papua Govt. Gaz. of 6th January, 1926.]

#### PROCLAMATION.

By His Excellency Sir John Hubert Plunkett Murray, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the Territory of Papua.

WHEREAS by Section 7 of the Judgments (Reciprocal Enforcement) Ordinance, 1925, of the Territory of Papua, it is enacted among other things that where the Lieutenant-Governor is satisfied that reciprocal provisions have been made by the Legislature of any other part of His Majesty's Dominions outside the United Kingdom for the enforcement within that part of His Majesty's Dominions of judgments obtained in the Central Court of the Territory of Papua, the Lieutenant-Governor may by Proclamation declare that the said Ordinance shall extend to judgments obtained in a Superior Court in that part of His Majesty's Dominions in like manner as it extends to a Superior Court in the United Kingdom:

And whereas the Lieutenant-Governor is satisfied that such reciprocal provisions have been made by the Legislature of the State of Western Australia:

Now, therefore, I, the Lieutenant-Governor aforesaid, in pursuance of the powers and authority in me vested, do hereby declare and proclaim that the *Judgments* (*Reciprocal Enforcement*) Ordinance, 1925,

aforesaid, shall extend to judgments obtained in the Supreme Court of the State of Western Australia in like manner as it extends to judgments obtained in a Superior Court in the United Kingdom.

WHEREAS by Section 7 of the Judgments (Reciprocal Enforcement) Ordinance, 1925, of the Territory of Papua, it is enacted that where the Lieutenant-Governor is satisfied that reciprocal provisions have been made by the Legislature of any part of His Majesty's Dominions outside the United Kingdom for the enforcement within that part of judgments obtained in the Central Court of the Territory of Papua the Lieutenant-Governor may, by Proclamation, declare that part to be a Reciprocating State for the purposes of the said Ordinance:

And whereas the Lieutenant-Governor is satisfied that such reciprocal provisions have been made by the Legislatures of the Colony of Fiji, the Northern Territory of Australia, the Territory of New Guinea and the Territory of Norfolk Island respectively:

Now, therefore, I, the Lieutenant-Governor aforesaid, in pursuance of the powers and authority in me vested, do hereby declare and proclaim the Colony of Fiji, the Northern Territory of Australia, the Territory of New Guinea and the Territory of Norfolk Island to be respectively Reciprocating States for the purposes of the Judgments (Reciprocal Enforcement) Ordinance, 1925, of the Territory of Papua.

WHEREAS by Section 7 of the Judgments (Reciprocal Enforcement) Ordinance, 1925, of the Territory of Papua, it is enacted that where the Lieutenant-Governor is satisfied that reciprocal provisions have been made by the Legislature of any part of His Majesty's Dominions outside the United Kingdom for the enforcement within that part of judgments obtained in the Central Court of the Territory of Papua the Lieutenant-Governor may, by Proclamation, declare that the said Ordinance shall extend to judgments obtained in a Superior Court in that part of His Majesty's Dominions in like manner as it extends to judgments obtained in a Superior Court in the United Kingdom:

And whereas the Administrator is satisfied that such reciprocal provisions have been made by the Legislature of Straits Settlements:

Now, therefore, I, the Administrator aforesaid, in pursuance of the powers and authority in me vested do hereby declare that the Judgments (Reciprocal Enforcement) Ordinance, 1925, shall extend to judgments obtained in a Superior Court of Straits Settlements in like manner as it extends to judgments obtained in a Superior Court in the United Kingdom.
