EXEMPTION FROM IMPORT DUTY

Customs Tariff Act 1983

AMENDMENT OF EXEMPTIONS FROM IMPORT DUTY

I, Kingsford Dibela, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 8 of the *Customs Tariff Act* 1983 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby amend, with effect from 1st January, 1984, the Exemption from Import Duty dated 27th April, 1983 and published in *National Gazette* No. G26 of 28th April, 1983 in the Schedule—

- (a) by omitting from Clause 2(b) the following-
 - "Papua New Guinea Electricity Commission"

"Papua New Guinea Harbours Board"; and

- (b) by adding at the end of Clause 2(c) "Bougainville Copper Limited Mine Training College"; and
- (c) by adding at the end of Clause 58(c) "or in the printing industry."; and
- (d) by adding at the end of Clause 58(d) "or as a printer.".

Public Service Act (Chapter 67)

DETERMINATION OF FUNCTIONS OF NATIONAL DEPARTMENTS

I, Kingsford Dibela, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 13 of the *Public Service Act* (Chapter 67) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consideration of report made by the Public Services Commission hereby amend, with effect from 1st January, 1984, the Determination of Functions of Departments dated 30th December, 1982 and published in *National Gazette* No. G86 of 31st December, 1982—

- (a) by adding at the end of Schedule 7 the following:-
 - "12. Advice and assist investors or potential investor.
 - 13. After consultation with any Department, instrumentality or other person or body that may be effected, recommend to the Government measures to attract investment to special areas of activities.".
 - 14. Advise and monitor Government planning for investment and action approved by the Government for the promotion of investment; and
- (b) in Schedule 9 by inserting after item 1 in Column 2 the following:-
 - "1A. Encourage and assist the formation and development of industrial organizations, in particular by— (a) fostering a better understanding of the role of industrial organizations amongst employers and the community generally; and
 - (b) stimulating and encouraging employers and employees to pursue industrial aims through registered industrial arganizations; and
 - (c) encouraging closer relations and understanding between industrial organizations of employers and industrial organizations of employees; and
 - (d) improving the administration and management of industrial organizations; and
 - (e) carrying out, stimulating and encouraging study and research into matters affecting industrial organizations.".
