Employment of Non-Citizens Act 2007

NOTICE OF EXEMPTION

I, Mark Maipakai, MP., Minister for Labour and Industrial Relations in exercise of the powers conferred on me under Section 51(1)(a) of the *Employment of Non-citizens Act* 2007 do hereby exempt the following non-citizens from all of the requirements of the said Act.

In accordance with the requirement of Section 51(3) I hereby grant approval of these exemptions in the interest of the nation and for a good cause, particularly in view that PNG currently lacks geotechnical specialists to be hired in country. The abovementioned non-citizens have been exemption from all of the requirements of foreigner work permits, dated from 20th November, 2009 to 31st December, 2009.

A specific condition placed against this exemption is that the non-citizens involved are required to provide opportunities for human resource development and skills training to citizen workers in the specified jobs within the approved period.
