AN ACT TO APPROPRIATE AN ADDITIONAL TWO HUNDRED AND FORTY TWO MILLION, NINE HUNDRED AND FIFTY FOUR THOUSAND, ONE HUNDRED AND THIRTEEN DOLLARS, TO THE SERVICE OF THE YEAR ENDING 31ST DECEMBER 2013.

ENACTED by the National Parliament of Solomon Islands.

2013 SUPPLEMENTARY APPROPRIATION ACT 2013

Short title and commencement

This Act may be cited as the 2013 Supplementary Appropriation Act 2013 and commences on the date ("commencement date") of assent.

Authorisation and appropriation of \$242,954,113

- The issue from the Consolidated Fund is hereby (1) authorised of a sum of two hundred and forty two million, nine hundred and fifty four thousand, one hundred anf thirteen dollars, to be applied to the service of the year ending 31st December 2013.
 - The sum specified in subsection (1) shall be deemed to have been appropriated as from the commencement date for the supply of the heads and in the amounts respectively specified for such heads, as set out in the Schedule.

Offsetting Savings -The appropriations specified Variations in Appropriation Act 2012 are hereby reduced by thirty nine Appropriations of-\$39,163,000 million, one hundred and sixty three thousand dollars as set

out in the Schedule.

Contingencies warrants

- The Minister may, from the commencement date until 31st (4) December 2013, and pursuant to section 15 of the Public Finance and Audit Act (Cap.120)
 - for the Heads of Recurrent expenditure, authorise under (a) contingencies warrants such sums not exceeding twenty five million dollars; and
 - for the Heads of Development expenditure, authorise under (b) contingencies warrants such sums not exceeding ten million dollars.


