**EMERGENCY POWERS (COVID-19) REGULATIONS 2022**  
**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO**  
**SOLOMON ISLANDS) (NO. 63) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 63) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

Each person specified in the Schedule may enter Solomon Islands on or about 26 May 2022 despite the prohibition under regulation 7(1) of the Regulation.
