**PROVINCIAL GOVERNMENT ACT 1997****THE CENTRAL PROVINCE ELECTORAL  
ARRANGEMENTS ORDER 2010**

IN exercise of the powers conferred by section 7 of the Provincial Government Act 1997, on the basis of proposals made by the Boundaries Commission, with the consent of the Cabinet and following consultation with the Central Province Provincial Assembly, I **Bradley Tovosia**, Minister of Provincial Government and Institutional Strengthening, hereby make the following order:

Citation and  
commence-  
ment

1. This Order may be cited as the Central Province Electoral Arrangements Order 2010 and will come into force on the date it is published in the *Gazette*.

Electoral  
arrangements

2. The electoral arrangements for Central Province will be as contained in the Schedule to this Order. One member will be returned for each electoral ward named in the Schedule.

Effect of  
Order

3. This Order will have effect on any election or subsequent elections of members of the Central Provincial Assembly conducted after the coming into force of this Order.

Repealed

4. All previous electoral orders for Central Province are repealed and replaced by this Order.

## Schedule

Name and Number of Ward	Boundary of Wards
1. SANDFLY/BUENA VISTA	An area bounded as follows: Commencing at a point east of Sandfly Island at map reference 625,150E and 9,008,000N; thence south-westerly by Sandfly passage to a point at map reference 617,800E and 9,001,640N; thence westerly by a straight line and including all islands north and west of Sandfly and Buenavista.
2. WEST NGGELA	An area bounded as follows:-  Commencing at the point of the Maneilaila River at map reference 628,900E and 9,004,450N; thence southerly by a straight line to a point at map reference 628,150E and 8,994,800N; thence westerly to a point at map reference 624,900E and 8,996,000N; thence south-westerly to a point at map reference 624,250E and 8,995,600N; thence southerly by a straight line and including all villages west and north of that line, north-east of the Sandfly Passage and to the point of commencement.
3. EAST NGGELA	An area bounded as follows:  Anuha Island and an area of Big Nggela west of a line commencing at a point on the northern coast at map reference 635,300E and 9,004,640N; thence southerly by a straight line to a point at the mouth of Kongga River at map reference 634,550E and 8,997,360N; thence southerly along the coast to a point at the mouth of the Takopikopi River at map reference 634,700E and 8,994,200N; thence by the same coast to Pitutetevi Point, then southerly by a straight line to a map reference of 634,000E and 8,988,800N; thence south-westerly by a straight line to a point at map reference 632,050E and 8,987,900N; thence northerly by a straight line to map reference 632,050E and 8,993,200N; thence north-westerly by a straight line to map reference 628,150E and 8,994,800N; thence northerly by a straight line to a point at the mouth of the Manoilaila River at map reference 628,900E and 9,004,450N; thence easterly along the coast to the point of commencement, including Anuha Island.

- 4. TULAGI** The islands of Tulagi, Mkambo, Mbangai, Koukomu-Tambu, Soghongola, Ghavutu, Ghaome, and Tanambogho bounded as follows:
- Commencing at a point at map reference 632,050E and 8,987,900N; thence northerly by a straight line to a point at map reference 624,900E and 8,996,600N; thence south-easterly to a point at map reference 624,250E and 8,995,600N; thence southerly by a straight line then bounding the above islands.
- 5. SOUTH-WEST NGGELA** An area of the islands of Big Nggela and Small Nggela bounded as follows:
- Commencing at a point on the south coast of Small Nggela at map reference 640,040E and 8,985,750N; thence north-westerly by a straight line to a point at map reference 639,000E and 8,989,450N; thence north-easterly by the Utuha Passage to a point at map reference 641,450E and 8,992,100N; thence north-westerly by a straight line to a point at the mouth of the Takopikopi River at map reference 634,700E and 8,994,200N; thence southerly by the coast to the Pitutevi Point, then by a straight line to a point at map reference 634,000E and 8,988,800N; thence south-westerly by a straight line to a point at map reference 632,050E and 8,987,900N; thence south-easterly including Pukunambua, Kokomu and Mandoleana Islands; thence easterly to the point of commencement.
- 6. SOUTH-EAST NGGELA** An area bounded as follows:
- Commencing at a point on the coast at a map reference 640,040E and 8,985,750N; thence north-westerly by a straight line to a point at map reference 639,000E and 8,989,450N; thence north-easterly by the Utuha Passage to a point at map reference 641,450E and 8,992,100N; thence easterly by a straight line to a point on the coast at map reference 652,900E and 8,989,100N; thence south-westerly by the coast to the point of commencement.
- 7. NORTH-EAST NGGELA** An area bounded as follows:
- Commencing at a point on the coast at map reference 652,900E and 8,989,100N; thence north-westerly by a straight line to a point on the Utuha Passage at map reference 641,450E and 8,992,100N; thence northerly following the Utuha Passage to a point at map reference 643,730E and 9,000,000N; thence south-easterly to the Vatundavala Point; thence southerly by the coast to the Mbambangile Point; thence easterly by the coast to the Hunivatu Point, thence southerly by the coast to the point of commencement.

- 8. NORTH-WEST NGELLA** An area bounded as follows:  
Commencing at the point on the Utuha Passage at a map reference 641,450E and 8,992,100N; thence northwesterly by a straight line to a point at the mouth of the Takopikopi River at map reference 634,700E and 8,994,200N; thence northerly by the coast to a point on the mouth of the Kongga River at map reference 634,550E and 8,997,360N; thence northerly by a straight line to a point on the coast at map reference 635,300E and 9,004,640N; thence easterly to a point at map reference 643,730E and 9,000,000N thence southerly following the Utuha Passage to the point of commencement.
- 9. BANIKA** The island of Banika in the Russel Islands group.
- 10. PAVUVU** An area bounded as follows: The island of Pavuvu in the Russell Islands group.
- 11. LAVUKAL** An area bounded as follows: All of the islands in the Russel Islands group except for Banika and Pavuvu.
- 12. NORTH SAVO** An area bounded as follows:-  
An area of Savo Island bounded as follows:  
  
Commencing at the mouth of the Mbonala River at Map reference 586,700E and 8,989,800N; thence north-easterly by a straight line to the peak at the highest point of the island at Map reference 589,570E and 8,991,359N; thence north-easterly by a straight line to a point on the coast at Map reference 590,900E and 8,993,700N; thence counter-clockwise along the coast to the point of commencement.
- 13. SOUTH SAVO** All that part of Savo Island that is not included in Ward 12 above.



