The Makira Ulawa Province 2003/2004 Appropriation Ordinance

#### AN ORDINANCE

TO

Appropriate Three millions nine hundred and fifty one thousand, eight hundred and thirty two dollars to the services of the financial year ending 31st March, 2004.

Enacted by the Makira Ulawa Provincial Assembly with the Assent of the Minister as follows:-

Short Title & Commencement

1. This Ordinance may be cited as the Makira Ulawa Province 2003/2004 Appropriation Ordinance 2003 and shall come into effect on the date it is assented to by the Minister of Provincial Government in accordance with section 30 of the Provincial Government Act 1997.

- Authorisation of issue of 2. \$3,951,832.00 from Provincial Funds.
- The issue of the sum of three millions nine hundred and fifty one thousand, eight hundred and thirty two dollars to be applied to the service of the financial year ending 31st March 2004.
- 3. The sum specified in the preceding section shall be appropriated for the supply of Heads and Subheads specified in the schedule and in the amounts respectively in relation thereto.

Passed by the Makira Ulawa Provincial Assembly this 16th day of May 2003.
