CUSTOMS AND EXCISE ACT (CAP. 121)

THE CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT) (NO. 29) ORDER 2007.

IN exercise of the powers conferred by Section 7 of the Customs and Excise Act, **I, GORDON DARCY LILO,** Minister of Finance and Treasury, do hereby make the following Order:-

- 1. This Order may be cited as the Customs and Excise (Import Duties) (Amendment) (No. 29) Order 2007 and shall come into force on the date of publication in the Gazette.
- 2. That part of the First Schedule to the Customs and Excise Act, entitled "IMPORT CLASSIFICATION AND TARIFF" is hereby amended by deleting the duty rates that appear for all imports under Pacific Island Trade Agreement (PICTA).
- 3. By deleting duty free rates under the Pacific Island Trade Agreement (PICTA) and inserting therefore the following duty rates:-
