# **ELECTRICITY (CHARGES FOR SUPPLY) (NO. 10) REGULATIONS 2023**

I, Hon. Bradley Tovosia, Minister for Mines, Energy and Rural Electrification, and I, Hon. Harry Kuma, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act* 2007, on the recommendation of Authority, make the following Regulations:

## 1 Citation

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 10) Regulations 2023*.

# 2 Commencement

These Regulations commence on 1 October 2023.

#### 3 Definition

In these Regulations:

"non-regular customer" means a customer who owns a generation facility and is connected through a kilowatt metre.

# 4 Charges for supply of electricity

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and
- (c) for non-regular customers are specified in Schedule 3.

# 5 Repeal

The *Electricity (Charges for Supply) (No. 9) Regulations 2023* (Legal Notice No. 52 of 2023) are repealed.
